A clear and concise statement for this ordinance is to amend Section 299-6a entitled "No Parking Anytime" to include Carlisle St. north from Ann St. to Demarest Ave., and Section 299-8f entitled "2 Hour No Parking" from 9 am to 12 pm to include S. William St. from E. Main St. to Palisade Ave. and E. Main Street from Summit St. to S. William St., as set forth in the ordinance.
