

**BOROUGH OF BERGENFIELD
PUBLIC NOTICE**

ORDINANCE 17-2500 - AN ORDINANCE AMENDING CHAPTER 299 OF THE CODE OF THE BOROUGH OF BERGENFIELD ENTITLED "VEHICLES AND TRAFFIC"

was introduced at a regular meeting of the Mayor and Council of the Borough of Bergenfield, in the County of Bergen, New Jersey, held on Tuesday, September 19, 2017 and will be further considered for final passage after public hearing at a meeting of the Mayor and Council to be held in the Executive Council Chambers, Bergenfield Municipal Center, 198 North Washington Avenue, Bergenfield, New Jersey on Tuesday, October 3, 2017 at 8:00 p.m. prevailing time, or as soon thereafter as the matter can be heard.

A clear and concise statement for this ordinance is to amend Chapter 299 of the Code of the Borough of Bergenfield entitled "Vehicles and Traffic" to remove certain streets in which parking is prohibited at all times, amend certain streets in which parking is prohibited during certain hours, to limit parking time on certain streets, amend parking hours in Borough parking lots, amend areas designated as handicapped parking, modify areas in which stopping or standing is prohibited at any time, amend turn restrictions on certain streets, and designate certain streets as one way streets during school hours only, as set forth in the ordinance.

**AN ORDINANCE AMENDING CHAPTER 299 OF THE CODE OF THE BOROUGH OF BERGENFIELD,
ENTITLED "VEHICLES AND TRAFFIC"**

WHEREAS, Chapter 299 of the Code of the Borough of Bergenfield sets forth all regulations regarding Vehicles and Traffic within the Borough of Bergenfield; and,

BE IT ORDAINED, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

Chapter 299. Vehicles and Traffic

299-6. entitled Parking Prohibited at all times on certain streets

299-6a. No person shall park a vehicle at any time upon any of the following streets or parts thereof, described below:

Ch. 299-28. entitled Through streets designated.

299-28a. Pursuant to the provisions of N.J.S.A. 39:4-140, the following streets or parts of streets are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street except where yield signs are provided for in the designations.

Ch. 299-29. entitled Traffic control signals.

299-29a Traffic control signals shall be installed and operated at the intersection of those streets described below. The traffic signals installation shall be in accordance with the provisions of Subtitle 1 of Title 39 of the New Jersey Statutes Annotated, and shall conform to the design and shall be maintained in operation as authorized by the Department of Transportation.

Intersection

Hickory Avenue and North First Street (Blinking Light)

Ch. 299-31 entitled One Way Street During School Hours Only

No person shall travel in the opposite direction on the below streets during school hours when barricades are in place with the exception for emergency vehicles in the event of an incident.

Franklin School – N Franklin Ave southbound traffic only from W Church St to Main St during school hours.

Hoover School – Northbound traffic only from Sylvan Ave to E Englewood Ave during school hours.

Jefferson School – Martin St southbound traffic only from Hickory to E Johnson Ave for employees only during school hours. Closed for all other traffic during school hours.

Jefferson School – Third St southbound traffic only from Phelps Ave to Hickory Ave during school hours.

Lincoln School – Schoolcraft Rd westbound traffic only from McGrath Lane to Schoolcraft Rd during school hours.

Washington School – S Summit St northbound traffic only from Palisades Ave to E Main St during school hours

Washington School – Palisades Ave eastbound traffic only for school employees from S Summit St to S Taylor St during school hours. Closed for all other traffic during school hours.

Ch. 299-32 entitled Veterans Parking

No person shall park a vehicle on the below street unless that person is a Veteran:

Lilac St 35 feet west of S Washington Ave for a distance of 50 feet

299-32b. **Violations and Penalties.** Any person convicted of a violation of a provision of this subsection or any supplement hereto shall be liable to a penalty of fifty-five (\$55.00) dollars.

Severability All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

Effective Date. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
