# ORDINANCE 18-2521 - AN ORDINANCE AMENDING CHAPTER 194 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "LIBRARY"

was introduced at a Work Session meeting of the Mayor and Council of the Borough of Bergenfield, in the County of Bergen, New Jersey, held on Tuesday, February 6, 2018 and will be further considered for final passage after public hearing at a meeting of the Mayor and Council to be held in the Council Chambers, Bergenfield Municipal Center, 198 North Washington Avenue, Bergenfield, New Jersey on Tuesday, February 20, 2018 at 8:00 p.m. prevailing time, or as soon thereafter as the matter can be heard.

A clear and concise statement is to amend section entitled "Failure to return borrowed items prohibited; notice and fees" and include that any patron accruing fines over \$50.00 for overdue materials shall be subject to legal proceedings, as set forth in the ordinance.

### BOROUGH OF BERGENFIELD Ordinance No. 18-2521

### AN ORDINANCE AMENDING CHAPTER 194 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "LIBRARY"

WHEREAS, Chapter 194 of the Code of the Borough of Bergenfield sets forth all regulations regarding the Library within the Borough of Bergenfield; and,

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

#### Chapter 194 - Library

Sec. 194-1 entitled Failure to return borrowed items prohibited; notice and fees. In addition to the fines and fees established by the Library Board for material type, loan period, overdue charge per day and replacement costs, any patron accruing fines over \$50.00 for overdue materials shall be subject to legal proceedings.

<u>Severability</u> All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

<u>Effective Date</u>. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
