Written Reports of the Department

Sam Yanovich reported that Influenza activity is "high" throughout the State. A brief conversation took place regarding the benefits of being vaccinated. Mr. Yanovich also reported that Bill S2173/A3818; the bill eliminating the religious exemptions to immunize school children passed the Assembly in December but was defeated in the State Senate by one vote.

Mr. Yanovich reported on the Salmonella outbreak linked to a produce company from New Brunswick that effected some people in New Jersey.

Mr. Yanovich reported on the increase of vaping related illness cases in New Jersey and one death. A study by the National Institute on Drug Abuse finds more teens are vaping marijuana and nicotine, but fewer are drinking alcohol or smoking cigarettes.

Kayla reported that she is reviewing all the food establishment files to determine how to move forward with the inspections.

Councilman Deauna reported that APNA; a food establishment in town will be closing soon.

A motion was made by Mrs. Pfannen seconded by Mrs. Marte and carried that the written December 2019 reports of the Department be accepted as written.

1. Mid-Bergen Contract

Mrs. Williams reported that effective January 1, 2020, the Borough of Bergenfield entered into a Uniform Shared Services Agreement with Mid-Bergen Regional Health Commission for local public health services.

2. Tyco Contract

Mrs. Williams reported that effective January 1, 2020, the Borough of Bergenfield entered into an Agreement with Tyco Animal Control Services. Tyco will provide animal control services and provide the health and welfare of the Borough.

3 H.A.R.P. Contract

Mrs. Williams reported that effective January 1, 2020, the Borough of Bergenfield entered into a contract with Health Awareness Regional Program and Hackensack Meridian Health for health education.

4. Medical Services Agreement

Mrs. Williams presented the Board with the contract between the Borough of Bergenfield and Dr. Nancy Rothenberg with no changes from previous year. The Board approved the contract as presented.

5. Salary Resolution

The Salary Resolution for the full time Health Department employees was presented to the Board without the adjusted hours and salary for the PerDiem nurses. After a brief discussion, it was the decision of the Board to pass the Resolution and amend it for the Per-Diem nurses when necessary. Resolution 2020-1 was offered by Dr. Cheriyan, seconded by Mrs. Pfannen as follows:

BE IT RESOLVED, by the Board of Health of the Borough of Bergenfield that the compensation during 01/01/2020-12/31/2020 of the officers and employees in Classified Service (Civil Service) be and the same is hereby amended, fixed and determined (35 hours week): (Resolution on file in the Health Department). BE IT FURTHER RESOLVED that the compensation shall be retroactive to January 1, 2020.

On roll call, all members present voted yes, Resolution was adopted.

VERBAL COMMUNICATION

Ms. August reported that there was an excursion in temperature from the refrigerated vaccines. It happened over the weekend and it was caused by an electrical problem. The problem has been fixed and the incident reporting and collateral information was submitted to the State Health Office governing VFC program. All vaccine clinics involving refrigerated vaccines are on hold until further notice.

A discussion took place regarding possibly purchasing a vaccine refrigerator in the future with an alarm to alert you of any temperature change at any time.

A discussion took place regarding drafting an ordinance to allow inspections of Nail/Hair Salons in Bergenfield.

Ms. August introduced Camille Burgess; an intern from Williams Paterson who will be working with Ms. August and another intern from Montclair on the 2020 Mayor's Wellness Program.

There being nothing further to come before the Board, on a motion by Mrs. Pfannen seconded by Mrs. Marte and carried, the meeting was adjourned Sine Die at 7:50PM.
