B. Vietnam Veteran Lapel Pin Presentation Ceremony.

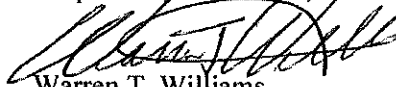
### **14. Committee Comments**
