Old Business:

Work Returned by Dan:

7 Pine (Q3) - removal request, new tree plant request, wants to plant smaller variety at her expense.

Private tree, no action necessary.

43 Brookview (Q3) - removal request, states cut in stem from power company. Trunk badly damaged, added to removal list.

Work Returned by Mike:

5 Momar (Q1) - tree was trimmed on 11/26/19, states tree is pulling up sidewalk 6 inches & also roadway. Phil N. inspected, Phil N. does not see 6 inch lift.

45 Grove (Q1) - tree inspection request, states roots are damaging foundation of house. Phil N. inspected, not a Borough tree, no action necessary.

Work Returned by Joe:

20 Lake (Q4) - removal request, states tree is dead. Joe's note: cannot determine if dead or not, wait until Spring to re-inspect; Phil N. inspected, tree is not dead, no action necessary.

Work Returned by Phil/DPW:

Marcotte & Seminary (Q3) - branch hanging in tree at corner of Marcotte Lane & Seminary Street. Work complete.

30 Dover (Q4) - trim request, is it Borough tree? Tree on Norfolk side is a Borough tree, added to trim list.

10-30 S. Washington (Q1) - 11/19/20 letter from Elite Mgmt of sidewalk lift from Borough trees, Elite Mgmt requesting Borough rectify situation immediately, tree removals or repair sidewalk possible? Phil N. received copy of certified letter on 12/1/20 & by email on 1/19/21.

35 Woods (Q2) - ~~prune & elevate.~~ CORRECTION to August 2020 minutes: PRIVATE tree, no action necessary.

10 Irving (Q1) - unoccupied house, neighbor at 3 Annex is requesting inspection of Borough trees at 10 Irving because branches come down in storms.

Assigned to Mike:

22 Shelley (Q1) - resident states tree looks sick, branches appear dry, branches fall on roof and front yard.

Assigned to Phil/DPW:

89 Ralph (Q2) - PSE&G contractor states that Maple tree is in decline, requesting approval to remove.

Other Business:

Thank you to Councilman Buddy Deauna (Council Liaison to Shade Tree Committee prior to 1/1/21), and welcome to Councilman Marc Pascual (Council Liaison to Shade Tree Committee as of 1/1/21).

The Borough submitted an application on 12/23/20 for a Green Spaces Grant (maximum award \$20,000.00), to replant mature trees at Cooper's Pond that were lost in recent storms and to provide virtual programming about trees/ecosystem/environment/conservation for residents.
