- 2. Parking Legal Mayor Amatorio stated the borough secured additional parking spots at Staples for borough workers and the public to park during the construction. There already are additional spots at Stop & Shop. They will designate some portions of the street on Phelps Avenue and Merritt Avenue for the construction workers when work becomes full blown during the daytime.
- 3. Capital Improvements Mayor Amatorio stated the borough is introducing tomorrow a ordinance to start work at Vivyen Park at Twin Boro Field and set aside funds for the cleaning of the brooks. Mayor Amatorio stated 2-3 years ago a \$2 million grant was obtained for the turf field at Twin Boro Park. The regional estimate was \$3.2 million and the bid results came back with \$4.6 million being the lowest bid. They will be able to bond the remaining amount that is sufficient for a number of years.

- 5. Liaison to Board of Adjustment Councilman Lodato stated he missed the last meeting but the hearing for Dunkin Donuts is still going on. Board member Bergman stated Dunkin Donuts was heard for about an hour and carried to next month's meeting. The board tried to schedule a special meeting but were not able to agree on a date. There were a couple of residential applications approved with simple, minor changes.
