

### **GARBAGE (G)**

GARBAGE PICK UP: Mondays & Thursdays (except for Holidays). GARBAGE MUST BE PLACED CURBSIDE BY 6:00 AM. GARBAGE: No paint, no chemicals, no recycling, no vegetative waste, no bulky items. Bagged household garbage ONLY. BULK PICK-UP: Maximum 4 large items & 2 appliances. No cardboard boxes. No rocks or asphalt. No tires. No TV's, No computers/monitors, laptops, printers, or fax machines. No construction/contractor debris. No fluorescent light bulbs. CONSTRUCTION DEBRIS: NOT ACCEPTED AT ALL. RESIDENTS ARE RESPONSIBLE FOR DISPOSAL OF CONSTRUCTION DEBRIS. WHITE METAL: Limit 2 on Bulk Day ONLY. Remove doors from refrigerators.

HOT WATER HEATERS: PERMIT STICKER REQUIRED. Call Building Dept. for permit: 201-387-4055 option 4. Bulk day pick-up. PAINT: Must be dried solid & put out for Bulk Pick-Up with lid off, or take to BCUA Household Hazardous Waste Event.

## **VEGETATIVE WASTE (V) - GRASS, LEAVES, BRANCHES, YARD WASTE**

VEGETATIVE WASTE PICK-UP: Tuesdays (except for Holidays) VEGETATIVE WASTE MUST BE PLACED CURBSIDE BY 6:00 AM ALL VEGETATIVE WASTE: April 7th-October 14th, place curbside in paper bags or 32 gal. size can or less. NO PLASTIC BAGS. BRANCHES: All year, must be cut into 4 ft lengths, bundled, tied & placed curbside for pick-up, including storm damage. RAKE TO CURB: October 15th-December 4th, grass and leaves only. DO NOT PUT BRANCHES IN LEAF PILES, PUT TO SIDE. DO NOT put leaves in the street after December 4th. After December 4th, leaves must be held until April 2021.

TEXTILES: Clothing, paired shoes & handbags ONLY. <u>NO</u> household debris or furniture. Bins at Twin Boro Lane.
