Annual Registration of ALL Two-Family Structures
And ALL Non-Owner- Occupied Single-Family Structures (Ord. No. 03-2307)

Enclosed is a Registration Form for your convenience which is required to be completed and returned **IMMEDIATELY**. The required fees are for rental units only and are as follows: \$50.00 for one family registrations and \$50.00 for each rental unit in a two-family dwelling. Please note that this fee will only be waived for Senior Citizens and Veterans who already have deductions filed with the Bergenfield Tax Department. This application must be notarized and it is your responsibility to schedule an appointment with this office. Please be advised that inspections are scheduled:

Monday, Wednesday & Friday from 9:00 a.m. to 12 p.m. and 1:00 p.m. to 4:00 p.m. Tuesday & Thursday 12:00 p.m. to 3:00 p.m. and 4:00 p.m. to 7 p.m.

A registration form must be completed even if you own and reside in a two-family house. Also, any single-family homes being rented must complete the enclosed form. When a tenant moves out and a new tenant moves in, you are required to update your registration by completing a new application supplying the new information. In the event a single-family residence is no longer being rented, you are required to contact this office in writing.

Please be advised that owners who do not comply with this ordinance will be subject to fines: not less than \$2,000.00 for the first offense.

Should you have any questions concerning the fee to be included with the completed form, please contact the Code Enforcement Bureau at the above referenced telephone number or visit the Code Enforcement office located in the Building Department in the basement of the Borough Hall. We will be pleased to assist you.
